Meeting was called to order at 7:21 p.m. by Commodore Gene Schertz. Previous meeting minutes (February 25, 2013) were read by Secretary Mackey. Motion to approve minutes as read made; seconded and approved unanimously.

### Old Business

- Rock Falls sponsorship has fallen through Race has been tabled.
- Rochelle will be the Divisionals. There will NOT be a Driving School. BSOA Commodore Swain still needs to be consulted about any Special Event(s) we add to the schedule (SLTs, marathon, etc.). We must state in every written public communication re: Rochelle, **“No alcohol, smoking, or drugs”** (per the Flagg-Rochelle Park District rules). This wording must be on the sanction/race circular. Pavlick will add to the MRC Facebook page; Mackey will add to the MRC website.
- MRC has three interested parties for the Driving School at Pell Lake (courtesy of John Korbus). The three have been contacted, but have not responded. Mackey will follow-up with them again. If there is a Driving School, MRC volunteers will run the program for BSOA.
- Meeting at the Sportsmen’s Club in Manteno, IL is set for April 2. Mackey, Pavlick, Pittman (Ray), and Schertz will make a brief presentation in an attempt to align the two clubs to bring racing back to Lake Manteno. Tentatively looking to set a first race date of July 2013, and hoping to foster an annual event.

- Phantom Lake is on for September 14-15. No news to report.

- The Parity Committee has approved the following changes for 2013 the season:
  - Lowering Sidewinder 15S to 1.75-inch for ASH.
  - Lowering 15 Mercury weight 15-pounds for ASH and ASR.
  - Allowing Sidewinder 20 in BSH and BSR classes with 0.750-inch restrictor plate and 30mm Dellorto Carburetor. Sidewinder 20 BSR height is 1.375-inch below; Sidewinder 20 BSH height is 1-inch below. All other rules for the B Classes apply.
