### **Old Business**

- Recap of Region 7 meeting held October 26, 2013 at the Antioch VFW Hall.
- Recap of the 2013 BSOA/MRC banquet and award recipients.
- Recap of 2013 BSOA races (Pell Lake, Rochelle, Neosho, Oshkosh, Phantom Lake, Koshkonong). Since Saturday was Divisionals at Rochelle (hosted by BSOA) and Sunday was declared a blow-out, technically MRC did not host any races in 2013.

### **BSOA Update**

- Bill Pavlick reports that BSOA is attempting to garner Historical Society funds for more radios (as most of the radios were non-functioning). BSOA is also attempting to secure Historical Society funds (\$1,000) for a digital display synchronized to the start clock that displays the countdown to the crowd.

### **New Business**

- 2014 schedule was loosely discussed. It was determined that MRC will concentrate on securing the Manteno, IL and Lake Station, IN for May 3-4 and Memorial Day Weekend respectively.
- Secretary Mackey will follow-up with Manteno Sportsmen's Club and Vice Commodore Pavlick will follow-up with Ed Hearn on Lake Station. (Hearn has volunteered to find sponsors and do pre-race legwork provided MRC hosts the race, which was agreed at the Region 7 meeting in October.)
- Potential Driving School on Memorial Day Monday at Lake Station (TBD).
- Considering asking MHRA to partner on Lake Station race. Pavlick to contact Elek Hutchinson to see if there is interest/potential.
- Discussed the possibility of a Driving School on a non-race weekend at a site TBD. Commodore Schertz will look into securing NBRA or AOF insurance, at which point further MRC discussion will be required if this plan can move forward.
- Bill Carter is keeping tabs on Candlewick, and Pavlick will contact Carter for any new developments.
